Dr. Fiander attended the Relay for Life session at the Clinton Township Middle School and said that the program was successful in raising money and in raising spirits on Friday night.

CTSD SECURITY

Recent tragic incidents remind us of the need to constantly re-evaluate the security of our schools. In the Clinton Township School District, we work closely with law enforcement officials to ensure that our staff and our students know what to do in an emergency. We continue to work on preventative measures and to remind our students that when they see something suspicious, it's critical to say something to an adult. And, our staff remains vigilant in working to meet the social and emotional needs of our students -- so that we can remain proactive in identifying potential risks.

The district has taken in the areas of safety and security, with over \$1.3 M invested in safety upgrades over the past few years. Since 2013, our District has been beneficiary of a strong relationship with the Prosecutor's Office and, in particular, Lt. Kevin Burd. Lt. Burd has made numerous visits to review safety procedures with both staff and administrators. As recommended, we use the *Standard Response Protocols* and consistently rehearse a variety of drills in all our schools, and the entire staff was trained and briefed on February 16th by Lt. Burd and John Michael Keyes (*I Love You Guys Foundation*).

Each of our four schools has a Building Emergency Response Team (BERT), which meets at scheduled intervals to review and update roles, check materials and supplies, check communication lists, and review drills. Updated information is then provided to staff at faculty meetings, and substitute folders have information relevant to substitutes during drills, and all classrooms have the color-coded drill protocols on display by the exits.

Even with a number of security measures in place, and more on the horizon, there is always more that we can do to ensure the safety of our students and staff. The following measures are being implemented:

- Increasing police presence on school campuses
- Registering school personnel on SHARE 911
- Installing a swipe card system at each front door
- Improving room and window signage in all buildings
- Obtaining reunification kits
- Practicing a reunification drill

Under review are to install a driver's license scanning system that will alert school personnel of visitors' criminal activities, wire the district's surveillance camera system so it is accessible by law enforcement personnel, and conduct a security audit of all buildings via an outside vendor.

Lt. Burd and John-Michael Keyes noted in their recent presentation that "We are not experts, we are students." They said they learn something from every incident and from other professionals. No one has all of the answers, nor can anyone predict the future. What we do know is that **nothing is more important than the health and safety of the children.** This comes first — even over educating them. We take safety and security very seriously and, in working with law enforcement officials, the Board of Education, and the staff, we will continue to keep this at the forefront of our attention.

Cristine Laudato, President of the Clinton Township Education Association (CTEA) spoke about the desire of the CTEA to make progress. She said that the CTEA has tried to make an amicable response and attain a fair settlement. Mrs. Laudato said that it seems as if the Board is attempting to "delay, deter, and disavow" the process. She commented that she was perplexed then she heard the Board say that there was mutual participation on both parties. She concluded her remarks by stating that the CTEA seeks resolution and said, "Let's get this done."

Chris Cosgrave, Third Grade Teacher at Patrick McGaheran School, stated that, "We have become an unhealthy district" and that honesty has been brought into question. He commented that last summer the Superintendent, Director of Technology and Director of Special Services left he district, and that something is not right. The CTEA has gone on for more that a year without a pay raise and questioned how ignoring the contract help the school process. The truth, hee stated, is that contract negotiations has not begun. In the Clinton Board of Education reorganization meeting, the Board voted in the same leadership. The message we received was "We don't care." He called to undo the damage and to bring change.

Stephen Fletcher, Annandale, stated that he saw something two years ago in the district and we are at the same point again and he asked why. He commented that in 2018 we are given the impression that the CTEA is delaying the process and questioned why the teachers would want to delay. He said that in social media he sees positive aspects of a fine staff. He said "Mrs. Grant, this is the second time we are here, is it time for someone else to step forward?" After the recent security issues, the teachers have been here everyday and feels that we need to assure the

next budget funds the teachers. He then said that he appreciated the Board Members services and that, "It's time to do the job you were elected to do."

Penny Perez McFadden, Teacher at Round Valley School, said that this is a confusing situation. She then said, "We want to come to an agreement." and "Let's get this done."

Susan Rivers, Teacher at Round Valley School, asked the board what goals they have for this year. She questioned why we should teach technology and what the role is of a teacher today. She stated that the answer is that it all depends on the day. Today, Mrs. Rivers stated ,that she was a recess referee. She concluded her remarks by asking, "What have we done to deserve the disdain of the members of the Board of Education?

Gina Hand, Clinton Twp, stated that she is amazed by our teachers. Mrs. Hand stated that there are amazing things we can do together. She said it hurts when you say the board members are disrespectful. She also said, "I see fantastic kids." She concluded her remarks by saying "Let's ask both sides to work together."

Chris Rush, Annandale, stated that the first seven years of living in the area she has been very involved. There are amazing teachers and kids. She said that she appreciates everyone's energies, but this is not the district she moved into. Her concern is for the children. She added that there are things going on with the children that are not being taken care of. She concluded her remarks by stating "our children need us."

Mr. Maloy, Board Member, stated that being a Board Member, one expects heat. What he heard tonight was a direct attack on the Board President as a person. He stated that giving an ovation to someone who attacks a board president upset him.
